

# BLACK LGBTQ+ EVENT MINI-GRANTS

## Purpose

We provide community grants for Black LGBTQ+ events and festivals that cultivate Black LGBTQ+ legacy while also strengthening collaboration with Black LGBTQ+ communities and highlighting the voices of marginalized communities, such as LGBTQ+ people, those experiencing housing insecurity, those with disabilities, and seniors.

## Neighborhood Served

This grant benefits the following historically Black San Francisco neighborhoods: Bayview-Hunters Point, Fillmore/Western Addition, Ocean View-Merced Heights-Ingleside, Potrero Hill, and Visitacion Valley. The grantee must be familiar with one or more of these neighborhood legacies, either through research or personal experience.

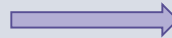

  3. Complete an interview with the mini-grant team

  2. We will ask detailed questions in order to learn more, including making sure there is a detailed budget
  3. We will follow up after a decision has been made

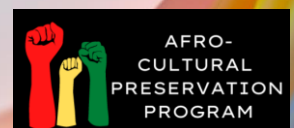

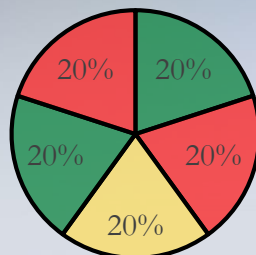

# AFRO-CULTURAL PRESERVATION PROGRAM MINI-GRANT

## Decision Making Process



**Organized** Are the vision and proposal well-organized?

**Achievable** Is the event/festivity presented in a way that is achievable and demonstrates capacity to achieve the goals of the event?

**Uplifting** Will this event uplift San Francisco and the Black LGBTQ+ community and its legacy?

**Fiscally Responsible** Is there a reasonable and well-thought out budget? Should it be approved for a lesser amount than requested, does the applicant have the capacity to fulfill the event?

**Affirming** Is the applicant Black LGBTQ+ affirming and community-engaged? Does the organization/individual have strong community support?
